~ PERMIT CONDITIONS ~

At the time of application, the Applicant was presented with conditions and agreed to follow those conditions, as well as any additional conditions set by the Fire Guardian. Those conditions are outlined below:

It is the responsibility of the Applicant to be familiar with and abide by the requirements of the Forest and Prairie Protection Act (SUPRA), the regulations thereunder, Flagstaff County's Fire Bylaw, and the following:

- Call your local fire chief prior to burning and have a cell phone available for use on site;
- Have an adult supervise the burn;
- Burn under favourable conditions with winds less than 16 km per hour;
- Ensure adequate fire guards are in place;
- Ensure the fire is extinguished by the expiry date shown on this permit;
- No burning of prohibited materials under the Alberta Environmental Protection Act;
- Priority consideration must be given to neighbours to avoid any physical discomfort as a result of burning which could require the burning to be stopped (this includes offensive odours and nuisance smoke);
- Smoke is not allowed to drift across any highway;
- Any time smoke begins to obscure visibility on highways, the fire must be extinguished immediately;
- The permit may be cancelled at any time and always if there is a local Fire Ban;
- Any additional conditions, as assigned by the Fire Guardian.

In addition to the above, the Applicant must also:

- Agree to follow all rules, regulations and conditions of this fire permit and accept all responsibility;
- Agree to pay all fire fighting costs due to any fire out of control as a result of this burn;
- Agree to contact Flagstaff County at (780) 384-4100 for pre-approval when burning stubble;
- Agree to indemnify and save harmless Flagstaff County from all liability arising out of temporary operations authorized by the issuance of this fire permit.
